REFERRED TO COMMITTEE ON ENVIRONMENTAL RESOURCES AND ENERGY, MARCH 23, 2020

AN ACT

- Amending the act of July 28, 1988 (P.L.556, No.101), entitled "An act providing for planning for the processing and 2 disposal of municipal waste; requiring counties to submit 3 plans for municipal waste management systems within their 4 boundaries; authorizing grants to counties and municipalities 5 for planning, resource recovery and recycling; imposing and 6 collecting fees; establishing certain rights for host municipalities; requiring municipalities to implement 8 recycling programs; requiring Commonwealth agencies to 9 procure recycled materials; imposing duties; granting powers 10 to counties and municipalities; authorizing the Environmental 11 Quality Board to adopt regulations; authorizing the 12 Department of Environmental Resources to implement this act; 13 providing remedies; prescribing penalties; establishing a 14 fund; and making repeals," in general provisions, further 15 16 providing for definitions.
- 17 The General Assembly of the Commonwealth of Pennsylvania
- 18 hereby enacts as follows:
- 19 Section 1. The definitions of "municipal recycling program"
- 20 and "municipal waste" in section 103 of the act of July 28, 1988
- 21 (P.L.556, No.101), known as the Municipal Waste Planning,
- 22 Recycling and Waste Reduction Act, are amended to read:
- 23 Section 103. Definitions.

- 1 The following words and phrases when used in this act shall
- 2 have the meanings given to them in this section unless the
- 3 context clearly indicates otherwise:
- 4 * * *
- 5 "Municipal recycling program."
- 6 (1) Any of the following that is operated by or on behalf of a municipality:
- 8 <u>(i)</u> A source separation and collection program for
 9 recycling municipal waste or source-separated recyclable
 10 materials[, or a].
- (ii) A program for the source separation and
 collection of post-use polymers or recovered feedstocks.
- (iii) A program for the source separation and
 collection of materials that are demonstrated to replace
 fossil fuels as an alternative energy source.
- (iv) A program for designated drop-off points or

 collection centers for recycling municipal waste or

 source-separated recyclable materials[, that is operated

 by or on behalf of a municipality].
- 20 (2) The term includes any source separation and
 21 collection program for composting yard waste that is operated
 22 by or on behalf of a municipality. The term shall not include
 23 any program for recycling construction/demolition waste or
 24 sludge from sewage treatment plants or water supply treatment
 25 plants.
- "Municipal waste." Any garbage, refuse, industrial lunchroom
- 27 or office waste and other material, including solid, liquid,
- 28 semisolid or contained gaseous material, resulting from
- 29 operation of residential, municipal, commercial or institutional
- 30 establishments and from community activities and any sludge not

- 1 meeting the definition of residual or hazardous waste in the
- 2 Solid Waste Management Act from a municipal, commercial or
- 3 institutional water supply treatment plant, wastewater treatment
- 4 plant or air pollution control facility. The term does not
- 5 include source-separated recyclable materials <u>or post-use</u>
- 6 polymers or recovered feedstocks where the polymers or
- 7 <u>feedstocks are converted through technologies such as pyrolysis</u>
- 8 or gasification.
- 9 * * *
- 10 Section 2. This act shall take effect in 60 days.
