# Advisory Board

- WASTECON
  - BOD, AB and Chapter Officers are eligible for a discount on their WASTECON registration by using the code 2022CONNECT. In addition, early bird registration is available for other members. Please register for WASTECON and make hotel reservations at one of the hotels near the SD Convention Center.
- Strategic Plan
  - Approved by Board of Directors. Staff is having discussions about how to prioritize the various objectives and strategies in the Plan, and we encourage you to review the Plan and share it with chapter leaders and others. We will likely hold some outreach events with members concerning the Plan – please keep an eye out for them!
  - The Plan is on the SWANA website. (lower right side in orange). Please share this link with others. We look forward to working with all of you, and many others, to implement the new Strategic Plan.
- International
  - SWANA entered into an MOU last week with USAID's Clean Cities Blue Oceans program, which provides an opportunity for SWANA and its members to provide technical assistance and capacity building to USAID clients in developing nations, with a focus on coastal locations. The MOU focuses on reducing plastic pollution, and builds on a similar MOU that SWANA entered into with the Inter-American Development Bank (IDB) in late 2021 and a new project in Brazil focusing on landfill training through the US Commerce Department in late 2022 and 2023.
  - Yesterday, the US EPA invited SWANA to participate in the Organization for Economic Cooperation and Development's (OECD) environmental performance review of the United States, which is focused on marine litter with environmental justice as a cross-cutting issue. There will be a series of meetings in mid-September involving

top EPA officials, OECD representatives, and invited stakeholders. SWANA staff is reviewing the invitation and what we would present to the attendees.

- Safety
  - There have been a disturbing number of fatal incidents involving the solid waste industry over the past 6 weeks. There have been 16 deadly incidents since July 1st, including 7 in which a solid waste worker was killed. SWANA is reviewing the uptick and evaluating whether the distribution of any sort of "alert" or additional safety resources to SWANA members and others is warranted. We are holding a Safety Summit at WASTECON and will be announcing the Safety Awards winners on September 6th.

# Safety Ambassador

• Fatal incident that occurred on Friday, August 26 in Butler County, Pennsylvania. Just before 4:30 am, one collection vehicle collided with another collection vehicle on Mars Valencia Road. This caused the first truck to crash into an unoccupied building from which he had to be extracted. He later died from the injuries received. The driver of the other truck was taken to the hospital but was reportedly not seriously injured. We have been in contact with the company that suffered the fatality and will provide additional information as appropriate. Further details are available via the link below.
